for Collection, Use and Disclosure of Personal Information

Please read this release and consent carefully, and sign in the spaces below. All people 16 years of age and older who live in the unit must sign this.

RELEASE AND CONSENT

1. I understand that Victoria Park Community Homes Inc. and Victoria Park Community Homes Management Project (collectively referred to as "Victoria Park") are required and authorized to collect personal and financial information about me, pursuant to the provisions of the *Housing Services Act, 2011* and its Regulations. I further understand that I am not required to supply this information to Victoria Park, but if I do not supply this information, I will not be eligible to become a tenant of a subsidized/rent-geared-to-income rental unit.

2. Should I choose to provide Victoria Park with my personal and financial information, I understand and consent to Victoria Park releasing this information as it is required to do so by the terms and conditions of *Housing Services Act, 2011* and its Regulations to various Social Services Offices, Municipal Service Managers¹, District Social Service Administration Boards, and Housing Providers, without further notice to me. I further understand and authorize that Victoria Park may release this information, if it is necessary to make decisions about my eligibility for housing assistance, under the *Housing Services Act, 2011*, the *Ontario Works Act, 1997*, the *Ontario Disability Support Program Act, 1997*, and the *Day Nurseries Act*.
3. Furthermore, I authorize and consent to the releasing of the information on this Consent Form and the attached Rental Subsidy Application and Statement of Employment Earnings by Victoria Park to any department, ministry or agency of the Government of Canada without further notice to me if this information is necessary for the purpose of the Government of Canada and its various ministries, agencies and departments, in administering and enforcing the *Income Tax Act (Canada)* or *Immigration Act*. I acknowledge that Victoria Park has an obligation and commitment to the Government of Canada to share such information in the appropriate circumstances.
4. I consent to Victoria Park making various inquiries of any financial institutions including, but not limited to, banks, trust companies and credit unions with respect to any item of information contained in this Consent Form and the attached Rental Subsidy Application and Statement of Employment Earnings with respect to any bank accounts, safety deposit boxes, financial assets, employment income, investment income or any sources of income or assets whatsoever of any nature or kind (collectively referred to as my "assets"), whether my assets are owned alone by me personally or jointly with any other person, or owned on behalf of any of my dependents or children, whether permanently or temporarily in my care, or are owned by a person on my behalf as beneficial owner.
5. I consent to Victoria Park releasing the information on this Consent Form and the attached Rental Subsidy Application and Statement of Employment Earnings to any other government agency, be it municipal, provincial or federal, with whom Victoria Park has an agreement under the *Housing Services Act, 2011* or any other housing agreement without further notice to me for the purposes of conducting research and investigations relating to any social benefit program or social housing or rent-geared-to-income assistance program.
6. I understand that any information on this Consent Form and the attached Rental Subsidy Application and Statement of Employment Earnings released by Victoria Park to any governmental entity listed above is confidential and will only be given and used in accordance with the provisions of the *Housing Services Act, 2011*, the *Ontario Works Act, 1997*, the *Ontario Disability Support Program Act, 1997*, and the *Day Nurseries Act*, the *Income Tax Act (Canada)* and the *Immigration Act*.
7. I consent to Victoria Park conducting and receiving, through its employees, credit information from any credit agency or other source of credit information.
8. You give your consent and authorization to us to disclose to municipal, provincial, or federal departments and any agency that assists in the provision of social housing, social agencies which provides social assistance, or any credit information company, a collection agency, to any private or social housing landlord, any Consolidated Municipal Services Manager or District Social Service Administration Board and the Provincial-wide Arrears Database, all information will be used by the individual Coordinated Access systems in the province of Ontario, as part of the screening process for the applicants for social housing and for the collection of arrears. **In the event I place insurance coverage with SoHo Insurance Inc. I consent for SoHo Insurance Inc. and Victoria Park Community Homes to share information pertaining to my insurance particulars as a client of SoHo Insurance Inc. and as a tenant of Victoria Park Community Homes Inc.**

DECLARATON

I declare:

1. I declare that everything I have written in this document is true and that no information that is required to be given has been withheld or omitted.
2. I understand that all information I give to Victoria Park Community Homes will belong to them and they will give my information to the housing providers I have chosen. *(If applicable)*
3. I understand that only the people I have listed on this document may live with me in subsidized housing.
4. To share the information as may be set out pursuant to the provisions of this Consent Form and the attached Rental Subsidy Application and Statement of Employment Earnings.
5. I declare that I am in Canada legally.
6. I understand that I must pay back or arrange to pay any money I may owe to any subsidized housing provider.
7. I understand that it is an offence, under the *Housing Services Act, 2011*, for an individual to knowingly obtain or assist a household member to obtain rent geared to income assistance for which they are not entitled. Such an offence carries up to a \$5,000 fine or up to 6 months imprisonment as well as a prohibition from re-applying for assistance for a minimum period of two years. If something on this document is missing, incorrect or false, Victoria Park Community Homes may request additional information or may cancel my eligibility for subsidy or special needs housing.
